## (15/159) Apologies for Absence

## (15/160) Minutes of a meeting of the Parish Council held on 16 December 2015 It was RESOLVED that the minutes of a meeting of the Parish Council held on 16 December 2015 be signed as a correct record of the meeting.

## (15/161) Declarations of Interest and Gifts and Hospitality

Cllr Muskett declared a pecuniary interest in agenda item 8 (ii) as he is a neighbour of the property

Cllr Curr declared a non-registerable interest in agenda item 14 (a) as the production is due to be held in All Saints Church and he is a churchwarden.

There were no applications for dispensations and no declarations of gifts and hospitality.

#### (15/162) Chairman's Announcements

The Chairman wished members a Happy New Year and thanked everyone for their efforts in 2015.

## (15/163) Public Participation

There were no members of the public present.

## (15/164) Cornwall Councillor's Report

Cllr Mustoe reported that he will be chasing up actions from the Menagwins Odour Liaison Group meeting held on 22 November prior to the next meeting.

## (15/165) Devon and Cornwall Police Report

The Clerk reported that one crime had been reported in the period 14 December – 19 January, and this was a burglary at a farm building in Roseweek.

The Chairman reported that Tregorrick residents are to set up a closed Facebook group to circulate details of anything suspicious to other residents.

(i) PA15/11368: Land at Phase 2 Porthpean Road: Erection of 102 dwellings (substitution of house types for development approved under reference PA14/01101 reducing the site from 131 to 102 dwellings)

It was **RESOLVED that the Clerk should respond to the Planning Authority** (Cornwall Council) stating that the Parish Council objects to the proposal on the following grounds:

- 1. The Parish Council does not object to the proposed reduction in the number of dwellings, but does object to the reduction in the number of affordable homes, particularly given that Wainhomes' QC at the public inquiry for the original application cited the lack of affordable homes in Cornwall as a valid reason why the application should be approved.
- 2. The Parish Council is concerned about the loss of the green buffer adjoining Tregorrick Road and Porthpean Road.

Cllr Muskett left the room

(ii)PA15/11675 – Langley, Bridgemead Close, Tregorrick: Extensions and alterations to single storey dwelling to create a two storey dwelling and double garage

It was **RESOLVED that the Clerk should respond to the Planning Authority** (Cornwall Council) stating that the Parish Council objects to the proposal for the following reasons.

- 1. The adverse impact on the privacy and amenity of surrounding properties
- 2. The lack of on-site parking provision and the potential increase in traffic in this cul-de-sac

(b) The current situation regarding the following outstanding planning applications was noted

(i) PA15/09193 – Nanterrow, Tregongeeves Lane: Proposed dementia unit It was noted that this application has been refused

(ii) PA15/10188 – 1 Higher West End, Pentewan: Proposed construction of a dwelling house The Clerk had sought an update from the Planning Officer prior to the meeting but had not received a response.

## (15/167) Speeding in Tregorrick

The results of Cormac's Radarclass survey conducted in October 2015 were discussed. It was decided that the Clerk should arrange a meeting with the Highways Manager to discuss what Cormac proposes to do to reduce speeding through the village.

# (15/168) First Aid Training

The date is yet to be confirmed.

## (15/169) Weed spraying in the Parish

Quotes for weed spraying were considered. The Clerk was asked to ascertain from the contractor used last year why the price had increased so sharply and the matter will be revisited next month.

## (15/170) Pentewan Flood Defences

Cllr Avery and Cllr Ward will arrange to clear the area for the sandbag store. The Chairman and Cllr Ward are to meet to progress the Community Emergency Plan.

## (15/171) River Banks

There was nothing to report.

## (15/172) Menagwins Water Treatment Works/Levalsa Pumping Station

There was a problem with odours over Christmas, particularly at weekends. South West Water stated that there would be no cleaning so this could not have been the source. There is also still a problem with noise. These matters will be raised at the next liaison group meeting on 11 February.

## (15/173) Menagwins Car Park

The Clerk has received the Rating Notice from the Valuations Office. Members were dismayed that the Council would have to pay business rates on a free car park and Cllr Mustoe offered to pursue the matter with Steve Double, MP.

There are still problems with the cattle grid flooding and the Clerk will chase the Countryside Officer.

## (15/174) Highways Concerns

It appears that sat navs are directing motorists looking for Tregorrick Park into Bridgemead Close and Penscott Lane. The Clerk was asked to write to the rugby club and the football club asking if they could provide a sign for the bottom of Tregorrick Road stating that Tregorrick Park is <sup>1</sup>/<sub>2</sub> mile up the hill.

The Clerk was asked to contact Cormac to ascertain whether they removed granite blocks adjacent to the sailing club gate in the car park as these help prevent obstructions in the summer time.

The Clerk was asked to arrange a meeting with the Highways Manager to discuss various concerns in Tregorrick, including speeding as previously minuted.

The Clerk reported that Cornwall Council is no longer loaning No Waiting bollards to community groups for events but will donate a supply to parish councils. The Clerk has ordered 50.

The matter was carried forward to next month's meeting. Cllr Mustoe is to obtain a couple of sketches.

## (15/176) Pentewan Public Conveniences

(i) The Clerk has obtained a quote for installing paying mechanisms and will submit it to Cornwall Council for consideration under the Devolution Grant scheme.

The Clerk met with Cornwall Council's Surveyor who was carrying out a defects survey prior to handover. It appears that Cornwall Council is looking into providing paying mechanisms before handover and the Clerk has requested that Pentewan is considered for one of these. There is likely to be a service level agreement for the ongoing maintenance of such a unit and the Clerk is trying to ascertain at what cost this will be. It was **RESOLVED that the Parish Council would not request searches or search insurance as part of the legal process for handover.**
