I am now a resident of Pentewan Valley, at least until the boundaries change, having moved in on 31 July. I have taken a lot of time off for childcare purposes and while moving so have not been as busy as usual.

However, I have secured a promising update on the flood defence scheme in Pentewan. The officer's summary was:

'The situation is looking good and we are aiming to accelerate the project to start in 2021, if we can get all of the permissions and funding gateways completed.'

I hope you will have had the full report shared with you ahead of the meeting.

I also secured unhelpful replies about the situation at Pentewan Roundabout from Cormac and the Town Council.

However, with Tesco Express now going into the vicinity, as well as a pre application for 100 houses further down the road, this is more relevant than ever, and Parish Councillors may have seen the stand that myself and Mount Charles Cornwall Councillor Richard Pears took on this as per the front page of the St Asutell Voice today. The Parish Council's support for pressing for improvements to this would be much appreciated.

I also still have yet to have had a reply (although I have now had an acknowledgement) to my complaint about the horseshoe trail in Pentewan village. I have also recently had a call from a planning officer that mentioned that the Parish Council had asked me to call in an application in Pentewan village. I have not had any such request, but would consider it if asked.
